Product description

This is a two component, polyamide cured, high molecular weight epoxy coating. It has a semi gloss finish with fair gloss retention. It is a high build product. The coating is flexible, tough, abrasion resistant and has good adhesion. Can be used as primer, mid coat or finish coat in atmospheric environments. Suitable for properly prepared carbon steel, galvanised steel, stainless steel and aluminium substrates.
